or,

2) Providing nomination papers signed by 1% of the Credit Union Membership, and mailed or delivered, by the deadline of May 11, 2021, to the Secretary of the Board of Directors.

3) Nominations will not be accepted from the floor.

The qualified member must also submit the following information to the Board of Directors by the deadline, May 11, 2021:

1) A Statement of Qualification and Biographical Data, including work experience.

2) A Statement certifying that the individual, if elected, is willing to serve.

# Charles M. Giacoppe

Mr. Charles M. Giacoppe has been serving with the Board of Directors since 2015 when he was appointed as an Associate Director. He currently serves on the Asset Liability Management and the Personnel Committees.

Mr. Giacoppe has a private practice focusing in all aspects of personal injury claims, including extensive experience in civil action litigation before State and Federal Courts. He has also represents buyers and sellers in residential real estate transactions as well as commercial landlords in lease negotiations for office buildings and lenders in documenting loans secured by real estate.

Mr. Giacoppe has a B.A. in History with a minor in Political Science graduated cum laude. He also has Juris Doctorate from New England School of Law graduated cum laude (American Jurisprudence award).
