CENTRAL ONE AMAZON PRIME DAY PROMOTION

OFFICIAL RULES AND REGULATIONS

Promotion Description: The Central One Amazon Prime Day Promotion (the "Promotion") is sponsored and administered by Central One Federal Credit Union (the "Credit Union"). The Promotion gives eligible entrants the chance to win one of twenty (20) Amazon.com Gift Cards worth \$50 each or one grand prize (1) Amazon.com Gift Card worth \$250. No purchase is necessary and purchases will not increase the odds of winning a prize.

Promotion Dates: The Promotion runs from Tuesday, October 13, 2020 at 12:00 A.M. EST, through Wednesday, October 14, 2020 at 11:59 P.M. EST (midnight) (the "promotion period"). A random selection of winners (the "drawing") will be held on Thursday, October 22, 2020 (the "drawing date"), at Central One Federal Credit Union, Shrewsbury (Main) Branch, 714 Main Street, Shrewsbury, MA 01545.

How to Enter: You will automatically receive one entry to win each time you complete a purchase at Amazon.com during the promotion period when you use your Central One Diamond, Diamond Plus Cash, Business Solutions, or Future Focus Credit Card, or your Central One Debit Card. You need not be an Amazon Prime member to participate. Incomplete purchase orders will not qualify. **Alternative Method of Entry:** As an alternative, you may mail or deliver (in person) a letter with your name, contact information, and the words "Amazon Prime Day Promotion" to: Central One Federal Credit Union, Attn: Marketing, 714 Main Street, Shrewsbury, MA 01545. Mail-in entries must be postmarked from October 13 through October 14, 2020 and received by October 20, 2020. Entries delivered in person to the Credit Union must be delivered on October 13 or October 14, 2020 to the Main Branch in Shrewsbury (same address as above). Mail-in or delivered entries are limited to one per member per day. Central One Federal Credit Union is not responsible for lost, late, stolen, incomplete, illegible, inaccurate, undelivered, delayed, or misdirected entries.

Eligibility: The Promotion is open to all current members of the Credit Union who are legal U.S. residents and who are eighteen (18) years of age or older at time of entry. Winners must present photo identification to receive a prize. Employees, Officers, Directors, Volunteers and their immediate family members are excluded from participation in the Promotion. Immediate family is defined to include: spouses, siblings, parents, children, grandparents, and grandchildren, whether as in-laws or by current or past marriage(s), remarriage(s), adoption or other family extension.

Prize Description, Winner Selection, and Odds of Winning: There will be one grand prize \$250 Amazon.com Gift Card winner and twenty \$50 Amazon.com Gift Card prizes all awarded to twenty-one winners chosen at random on the drawing date. All eligible entries will be entered into the drawing. One prize per winner. You need not be present to win. Winners will be notified by email or by phone on the drawing date, using the email address or phone number on file. If an entrant's name is selected but cannot be reached by email or phone within three days of the drawing date, then another winner will be selected. Central One Federal Credit Union is not responsible for email addresses or telephone numbers that are no longer in service, misdirected, or otherwise undeliverable. The odds of being a winner depends on the total number of eligible entries received. All decisions are final and binding.

Winner List: After all prizes are awarded, a list of winners will be posted to the Credit Union's website and Facebook page.
